The Multiemployer Pension Plan Amendments Act (MPPAA), the Employee Retirement Income Security Act's (ERISA) progeny, can create significant unexpected liabilities for companies that have agreed to collective bargaining agreements (CBAs) requiring participation in and contributions to multiemployer-defined benefit pension funds (often referred to as Taft-Hartley Funds).
