# A Word from Our Diversity Committee Chair...

Jackson Lewis and Firm Chairman **Vincent Cino** continue to demonstrate a strong and continuing commitment to diversity and inclusion. As I am sure everyone has seen from Vincent's October 22, 2015 email, the Firm has created an Advisory Committee of Equity Shareholders to assist the Chairman and Board of Directors. What may not be immediately apparent is the diversity among members of the Advisory Committee, who were elected by the firm's Equity Shareholders. Of the 21 elected members of the Committee

(Vincent services as Chairman *ex officio*), 24% are women, 9.5% are African American, 9.5% are Asian American, and 5% are Hispanic. This level of diversity, encouraged by firm leadership and endorsed by the Shareholders' vote, will assist in ensuring that decisions on major issues will include a cross-section of diverse perspectives from around the Firm.

I also want to thank **Greg Alvarez (MOR)** and the entire Board of Directors for their leadership on diversity, implementing new initiatives to ensure that Jackson Lewis continues to be a leader among our peer law firms. Upon becoming Board Liaison to the Diversity Committee, Greg made one of his priorities to ensure that our Shareholders are thinking "diversity" when recruiting new lawyers. In particular, Greg has enhanced the Summer Associate program by requiring each office to participate (with an emphasis on diverse law students) and is similarly working to revitalize the JL Scholarship Program. From conversations with Office Managing Shareholders and incorporation of recruiting strategies into requests for Diversity Committee event sponsorship requests, there is new energy and awareness around recruiting and hiring diverse attorneys. The Board's engagement and energy on this effort will strengthen our client service and development capabilities.
