Hispanic Attorney Resource Group

The Hispanic Attorney Resource Group held a telephone conference on March 12th. The group will soon distribute its attorney survey to help determine the firm's resources for providing Spanish language legal services, including translating documents from English to Spanish and vice versa, interviewing witness, training managers in Spanish, or conducting workplace investigations. These services are one of the features that will help us distinguish us from our competitors and frequently allow us to further solidify relationships with existing clients such as Publicis and Barcel USA, or to get our "foot in the door" with organizations such as U.S. Foods. The focus for this year will be on publicizing the group's capabilities for these services both internally and externally.
