For the second year in a row, we have been recognized as a "Gold Standard Firm" by the Women in Law Empowerment Forum (WILEF). This designation is reserved for large firms that have successfully integrated female attorneys into their top leadership positions. To meet WILEF's requirements for Gold Standard designation, we successfully showed that female attorneys are well represented among our equity partners and hold key leadership positions, including on governance and compensation committees, and that the firm
