A Word from Our Diversity Committee Chair...

Latham Diversity Committee Chair Several months ago, the Executive Vice President, General Counsel and Secretary of a major insurance company asked me to be the keynote speaker at the opening night session of his Legal Department Retreat that included all of the company's lawyers, compliance officers, government relations executives, and senior legal staff. At the opening reception, I met several of the company's senior attorneys and more than five of them volunteered

The task the General Counsel assigned me was to speak to the entire legal team in the context of a Legal Department that perceives itself as a leader in diversity and inclusion ("D&I") within a company that prides itself on being a national leader in D&I—e.g., the CEO regularly makes strong public statements that emphasize D&I as a key component of the company's overall strategic plan. The General Counsel asked me to be both thought-provoking and challenge his legal team.

Our research revealed that the company has excellent D&I programs, and the Legal Department requires its outside law firms to ensure that minorities and women play key roles in its representation and specific matters. The Law Department could serve as a model for diversity and inclusion enhancement across the company. Diversity is an area many large companies are seeking to improve, but do not have in-house "diversity" expertise. Based on my experience with this and other clients, assistance with D&I is the kind of "value added" that General Counsel prize in their outside counsel. I encourage JL attorneys to seek to identify other companies where a discussion of D&I efforts could lead to broader opportunities to work with the client. I would be pleased to work with any of you who think your clients would welcome such a discussion.




